THE INFORMATION SHEET FOR MAINE TRAILER REGISTRATION ORDER FORM

Documents that must accompany the request for a **new-registration** or **plate transfer**

We break this down into two categories for ease of explanation

1994 or OLDER TRAILERS & ANY TRAILER WEIGHING LESS THAN 3000 LBS (Title Exempt)	1995 and NEWER TRAILERS (Title or Manufacturer's Certificate of Origin Required)
<p>Two ways to register these trailers:</p> <ol style="list-style-type: none"> 1. To register a 1994 or older trailer in Maine that you have registered in another state before – simply send us a copy of your registration. 2. If the 1994 or older trailer has never been registered by you before; we will need a legible “Bill of Sale” showing both the sellers and the buyers names and addresses. eg. This could be the title showing that the ownership has been transferred to you or a simple and legible “bill of sale”. <p>NOTE: To be tax exempt you must use the trailer 80% of the time for interstate or foreign (commercial) commerce, or have paid sales tax elsewhere. If tax is due, it is taxed at 5.5% of the purchase price..</p> <p>NOTE: To register live in trailers, eg. Campers, horse trailers with a live-in section and etc., a Maine Excise Tax is due immediately. <i>(Not to be confused with sales tax)</i></p>	<p>Two ways to register these trailers:</p> <ol style="list-style-type: none"> 1. If you currently have a title in your name; all we need is a photo copy of the title. 2. If you do not have a title in your name (eg. just acquired the trailer), you will need to title the trailer in Maine to register the trailer in Maine. <ul style="list-style-type: none"> • We will need the original title or Manufacturer's Certificate of Origin showing that the ownership has been transferred to you. Please be sure that it shows both of the buyers and the sellers signatures and addresses. • We will need the notarized limited POA signed allowing us to make application for title for you. <p>NOTE: To be tax exempt you must use the trailer 80% of the time for interstate or foreign (commercial) commerce, or paid the sales tax elsewhere. If tax is due, it is taxed at 5.5% of the purchase price.</p>

INSTRUCTIONS FOR RE-REGISTRATIONS, LOST PLATES, and DUPLICATE REGISTRATIONS:

<p>To Re-Register a trailer that you have registered in <u>Maine</u>; We need a copy of your registration or make, year, plate number, style, VIN and name and address of Registrant.</p> <p>If you are renewing a registration that was processed with L A Delano Agency LLC, then all we need is the trailer VIN number; we send out notices prior to the expiration date on trailer registrations we process.</p>
<p>LOST PLATE: You will need to send us your original registration to get a replacement or VIN for current customers.</p>
